JOINT AVIATION REQUIREMENTS - FLIGHT CREW LICENSING 1 (AEROPLANES) AND 2 (HELICOPTERS) ARRANGEMENTS FOR THE INTRODUCTION OF THE NEW THEORETICAL KNOWLEDGE EXAMINATION SYLLABUS.

1 Introduction

1.1 Notice of Proposed Amendment NPA-FCL 25⁽¹⁾ included a major revision of the theoretical knowledge examination syllabus. Following the established consultation process the new syllabus was adopted and is now incorporated into JAR-FCL 1, amendment 7 and JAR-FCL 2, amendment 6.

1.2 Following publication of the above amendments to JAR-FCL 1 and 2, a new set of learning objectives was published to align to the new syllabus and at a later stage a revised Central Question Bank was published to complement it.

1.3 EU regulations for licensing come into force on 8 April 2012. The 7 April 2012 is the last date upon which the Civil Aviation Authority (CAA) will be able to issue a JAR-FCL licence. From 8 April 2012 the CAA will issue EASA Part-FCL licences. Credit can be given for training and examinations completed before that date for the issue of EASA Part-FCL licences, but examinations taken after that date must be to the latest standard. For this reason no examinations to the old standard will be available after March 2012; (this includes re-sits). Where an applicant for a licence or rating has completed all of the examinations for that qualification to either the new or old standard by the end of March 2012, those examinations will be valid for the qualification; (subject to the usual calendar expiry). However, if an applicant who is sitting exams that are not to the latest JAR standard does not pass them all before 8 April 2012, the candidate will have to take all remaining subjects to the latest standard, and may have to retake others to that standard where the content of those subjects has changed.

2 Transition to the New Syllabus

2.1 Following consultation with the approved Theoretical Knowledge training providers, it has been agreed to provide examinations to candidates trained to the new syllabus from 1 June 2011.

2.2 Candidates who have already commenced training and examinations to the current syllabus will be able to continue with the existing examinations, subject to attempts and validity constraints, until 31 March 2012.

2.3 The CAA examination service team will make provision for both the existing and new syllabus examinations to be run in parallel. The intention is to administer both sets of examinations within the published timetable.

2.4 New application forms to denote the existing and new examinations will be published on the CAA website at www.caa.co.uk/forms. **Schools and their candidates must take care to apply for the appropriate set of examinations consistent with the syllabus they have studied.**

3 JAR-FCL 2 - Helicopter Theoretical Knowledge Examination Interim Arrangements

3.1 Helicopter Interim Arrangements examinations will cease on the 31 March 2012.
