

PRIVACY STATEMENT UNDER SECTION 13 OF THE PERSONAL DATA PROTECTION CODE (legislative decree No. 196/2003)

Dear User,

In accordance with the Legislative Decree No. 196/2003 (Personal Data Protection Code), S.A.T. (Società Aeroporto Toscano) S.p.A. wish to inform you that the processing of your personal data, will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Under Section 13 of the said regulations, we hereby provide you the following information:

PURPOSE OF THE PROCESSING OF PERSONAL DATA

Your personal data are processed in order to respond to requests for PPR (Parking Permission Request) and related services, to propose commercial offers after your explicit request, to manage all stages pre-contractual and contractual of the aforesaid services including administrative and accounting management and payments and to comply with explicit national and international statutory requirements including the application of rules and procedures laid down in the <u>Airport Rules of the Pisa airport.</u>

DATA CONTROLLER AND METHOD OF DATA PROCESSING

S.A.T. (Società Aeroporto Toscano) S.p.A. located in Pisa at Piazzale D'Ascanio, No.1, as data controller, collects and processes your personal data, you provide with the forms attached, for the specific services that you may require using forms, automated and telematics and strictly related to the purposes stated above. The data controller has appointed the data processors (whom you can ask the updated list to the above address). The data controller and the data processors may provide your data to respond to any requests by legal authorities or other public institutions entitled to request such information.

The data you provide will be kept only for the time required for execution of requests made, subject to your request for cancellation or modification of data, as required in Section 7 of Legislative Decree 196/2003. Your data or some of these may still be retained to comply with specific legal obligations.

CONSEQUENCES OF MISSING DATA AND NOT-AGREE TO THE PROCESSING

The providing of your personal data is always optional, however, in the absence of data marked with an * in the attached fax form and in any subsequent documents of data collection, the service or part thereof cannot be supplied and you could not receive the required services.

RIGHTS OF THE DATA SUBJECT

You can always exercise your rights under <u>Section 7 of D. LGS. No 196 /'03</u>, including the right of free access to your data, the immediately updated or canceled of it for violating the law, to object to the processing of your data for purposes of commercial information or advertising, and to request the complete and updated list of all the data processors.

WHO CAN BE AWARE OF YOUR DATA

Your personal data you sent to S.A.T. S.p.A., will be processed by persons in charge of the processing in the management of the required services and by data processors. This privacy statement can be supplemented with additional information depending on the requested service.

SUBJECT TO WHOM YOUR PERSONAL DATA MAY BE DISCLOSED

Your personal data will be disclosed to third parties to comply with explicit legal obligations national and international, or to comply with orders from public authorities or to pursue a legal claim. They are also communicated to external companies exclusively for the purposes for which they were collected.
